# Reports

## Recreation

Supt. Geary announced the departure of Heritage Park Sports Complex Manager. He has accepted a position with the Pontiac Park District. We will look to re-distribute the programs within the department. Summer staffing is moving along, and we plan to have the seasonal recreation staff in place by April 28. Spring is heavy with special event planning. Pickleball Grand Opening is this Friday, followed by Earth Day next week.

## Parks and Planning

The Parks Department is getting quite busy. We have a quote to remove the green shed. This is a fair price, and we will present a resolution for this next month. We had an Eagle Scout do his final project on the Bike Trail. The signs and entrances were cleaned, and the split rail fences repaired on Richton Road. Progress is being made on the Fitness Court. Supervisor Desiderio was able to secure a donation of the concrete and a discounted rate with the contractor for installation of the concrete pad.

The egg hunts are coming up this weekend. If anyone wants to volunteer contact Supervisor Metzner. Supt. Geary stated that Metzner is taking the lead on the event and is confident it will be a success in her absence. Supt. Geary noted all the upcoming special and cooperative events this spring. Earth Day has expanded to include cooperation with the Crete Police Department and Trinity Lutheran Church, The Pickleball Courts Grand Opening is on April 19, and we are co-sponsoring the Juneteenth Celebration with the School District and Monee Parks and recreation.

#### **Director's Report**

Director Chavez invited all the Commissioners to the Grand Opening of the Pickleball Courts this Friday. Parks Day at the Capitol is coming up in May. Supt. Biesterfeld, Director Chavez and Admin Asst. Healy will be attending. We will be looking into new software for the business end of the district as QuickBooks is no longer available for desktops. We have started the process of Strategic Planning with Campfire Concepts. They were extremely complimentary with the set-up and planning process of our budget and scorecard. Next steps will include the park audits.

Swiss Valley drawings were presented. The layout has become a challenge to make it a destination park, with the creek, the Village of Crete iron treatment building and underground set-up and the Thorn Creek Basin property. There was not enough clarity of the next steps when the playground was removed for the building's installation. The Fitness Court and the re-surfacing of the tennis courts will both be part of phase 1 during FY24/25. Thorn Creek Sanitary District is open to working on the re-do of the opening and access. We are working with getting them the drawings. We will be looking to start applying for grants in 2026. We will be looking at play features that will have height and a nature feel to look over the creek and into the natural areas of the park. C. Sharma feels that this will be great.
