The closet has been removed and the ceiling is getting fixed in the larger classroom on the lower level of Willard Wood and will soon be painted. M. Smith asked about the elevation of the concrete pad for the Fitness Court as it seems to low. Supt. Biesterfeld assured Commissioner Smith that he and lan from H3 Concrete shot all angles at the location and followed the specifications from the National Fitness Campaign. There will be landscaping that will need to be touched up and graded after the installation is complete.
